*Spinelli's Law Library Reference Shelf* is now available via [HeinOnline](#) (remote access available to most Jenkins members). This resource is a huge collection of materials that has been compiled by [Dick Spinelli](#), semi-retired Vice President of Hein. It has something for everyone - practicing attorneys, legal researchers, legal historians, law school professors, and law librarians. For example:

One publication that might be particularly useful to our attorney members is the *Legal Information Buyer's Guide and Reference Manual*. This publication, although not the current edition (according to Hein's contract with the publisher, they must delay the upload of editions by 2 years), is still useful for identifying the recommended treatises in specific areas of the law. If a practitioner finds himself outside of his usual practice area, he can check this publication to see what books are recommended in this unfamiliar area (and then check [our catalog](#) to see if Jenkins has them).

Similarly, the two state specific bibliographies, *Pennsylvania State Documents: A Bibliography of Legal and Law-Related Materials* and *State Documents Bibliography: New Jersey* may also be useful to the practicing attorney (as well as the law librarian responsible for collection development) as they list various Pennsylvania and New Jersey publications useful for researching legal issues in those jurisdictions.

To access *Spinelli's Law Library Reference Shelf*, log onto the Jenkins [home page](#) and then go to HeinOnline from the Member Center. The link to "the Shelf" can be found on the list of Subscribed Libraries. The materials in the collection can be listed by title, author, or date. They can also be listed by choosing a particular type of document (Legal Research Guides, Bibliographies, Legal Dictionaries, AALL publications, etc.). If you want to search an individual title, you can do that too, by going to Advanced Search, selecting the title, and then entering your search terms.

So, take a minute to explore this great resource and see what treasures **you** find interesting and useful!
